An Ordinance appropriating for all township road purposes for the Geneva Township, Kane County, Illinois, Road District for the fiscal year beginning April 1, 2012 and ending March 31, 2013.

Be it ordained by the Board of Trustees of the Geneva Township, Kane County, Illinois:

Section 1: That the amounts hereinafter set forth, or so much thereof as may be needed or deemed necessary to defray all expenses and liabilities of Geneva Township Road District, be and the same are hereby appropriated for the township road purposes of Geneva Township Road District, Kane County, Illinois, as hereinafter specified for the fiscal year beginning April 1, 2012 and ending March 31, 2013.

Section 2: That the following budget containing an estimate of revenue and expenditures is hereby adopted for the following funds:

Section 3: That the amount appropriated for purposes of the Township Road District of Geneva Township for the fiscal year beginning April 1, 2012 and ending March 31, 2013 by fund shall be as follows:

1. General Road Fund	\$	139,641.00
2. Permanent Road Fund	\$	370,008.00
3. Equipment and Building Fund	\$	93,000.00
4. IMRF Fund	\$	1,500.00
5. FICA Fund	\$	1,100.00
6. Liability Insurance Fund	\$	6,500.00
7. Bridge Fund	\$	-0-
TOTAL APPROPRIATIONS	\$	611,749.00

Section 4: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such decision shall not affect the validity of the remaining portion or this ordinance.

Section 5: That each appropriated fund total shall be divided among the several objects and purposes specified, and in the particular amounts stated for each fund respectively in Section 2, constituting the total appropriations in the amount of SIX HUNDRED ELEVEN THOUSAND SEVEN HUNDRED FORTY NINE DOLLARS AND NO CENTS (611,749.00) for the fiscal year beginning April 1, 2012 and ending March 31, 2013.

Section 6: That Section 3 shall be and is a summary of the annual Appropriation Ordinance of the Township, passed by the Board of Trustees as required by law and shall be in force and effect from and after this date.

Section 7: That a certified copy of the Budget and Appropriation Ordinance shall be filed with the County Clerk within 30 days after adoption.


