ORDINANCE NO. 012 -13

AN ORDINANCE FOR THE LEVY OF TAXES FOR ALL ROAD DISTRICT
PURPOSES OF THE GENEVA TOWNSHIP ROAD DISTRICT, KANE
COUNTY, ILLINOIS FOR THE TAX YEAR 2013 TO BE COLLECTED IN 2014

BE IT ORDAINED BY THE TRUSTEES OF THE TOWNSHIP OF GENEVA,
KANE COUNTY, ILLINOIS, as follows:

Section One: The Highway Commissioner of the Geneva Township Road District on December 19, 2013 does hereby determine and declare that the sum of TWO HUNDRED NINETY THOUSAND FIVE HUNDRED SIXTY TWO DOLLARS (\$290,562) is hereby levied upon all property subject to taxation within Geneva Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Geneva Township Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

- A. Road Fund
- B. Permanent Road Fund
- C. Equipment and Buildings
- D. Illinois Municipal Retirement Fund (IMRF)
- E. Liability Insurance
- F. Social Security

Section Two: That the amount levied for each object and purpose shall be as follows:

Fund No. 036: Road Fund	\$ 110.00
Fund No. 038: Permanent Road Fund	\$ 265,012.00
Fund No. 039: Equipment and Buildings	\$ 25,110.00
Fund No. 011: IMRF	\$ 110.00
Fund No. 003: Liability Insurance	\$ 110.00
Fund No. 012: Social Security	\$ 110.00

TOTAL LEVIED: \$ 290,562.00


Section Three: That the Geneva Township Clerk shall make and file with the Kane County Clerk, on or before the 30th day of December 2013, or may as otherwise be required by law, a duly certified copy of this Ordinance.

Section Four: That if any section, paragraph or provision of this Ordinance shall be held invalid or unenforceable for any reason, such invalidity or inability to enforce any portion shall not affect the validity of any of the remaining provisions of this Ordinance.

Section Five: That this Ordinance shall be in full force and effect upon and after its adoption, as provided by law.
