GENEVA TOWNSHIP ORDINANCE NO. _10_-16

Whereas, the Township Code of the Illinois Compiled Statutes, (50 ILCS 145/2) requires the Board of Trustees of Geneva Township set salaries for all elected township officials for the term of office commencing May 2017; and

Whereas, said salaries must be set at least 180 days prior to the commencement of said new term of office; and.

Whereas, the elected officials of Geneva Township are as follows: the Assessor, Clerk, Highway Commissioner, Supervisor and Trustees.

Now Therefore be it Ordained by the Board of Trustees of Geneva Township that the salaries for all township elected officials of the Township of Geneva as above stated are hereby set according to the provisions of this Ordinance.

Be It Also Ordained that the salary for the Geneva Township Assessor shall be as follows:

- 1. Salary: \$79,000.00 per year payable in equal installments on or about the first and fifteenth day of every month.
- 2. At the option of the Assessor, if otherwise qualified, participation in the Illinois Municipal Retirement Fund (IMRF) through Geneva Township.
- 3. At the option of the Assessor, Individual Health Insurance coverage under the insurance program(s) selected by the Township Board of Geneva Township. Participation in Individual Health Insurance coverage shall however be contingent upon the Assessor contributing 15% of each total monthly premium charged to the Township of Geneva toward the monthly health insurance premium payment for the Assessor, to be paid by payroll deduction each pay period.
- 4. At the option of the Assessor, Family Health Insurance coverage (spouse and/or children only) under the insurance program(s) selected by the Township Board of Geneva Township. Participation in Family Health Insurance coverage shall however be contingent upon the Assessor contributing one hundred percent (100%) of the monthly health insurance premium payment charged to the Township of Geneva for the Assessor's spouse and/or children, to be paid by payroll deduction each pay period.

Be It Additionally Ordained that the salary for the Geneva Township Clerk shall be as follows:

- 1. Salary: \$6,000.00 per year payable in equal installments on or about the first and fifteenth of every month.
- 2. At the option of the Clerk, if otherwise qualified, participation in the Illinois Municipal Retirement Fund (IMRF) through Geneva Township.

Be It Also Additionally Ordained that the salary for the Geneva Township Highway Commissioner shall be as follows:

1. Salary: \$25,000.00 per year payable in equal installments on or about the first and fifteenth of every month.

- 2. At the option of the Highway Commissioner, if otherwise qualified, participation in the Illinois Municipal Retirement Fund (IMRF) through Geneva Township.
- 3. At the option of the Highway Commissioner, Individual Health Insurance coverage under the insurance program(s) selected by the Township Board of Geneva Township. Participation in Individual Health Insurance coverage shall be contingent upon the Highway Commissioner contributing 15% of each total monthly premium charged the Township of Geneva toward the monthly health insurance premium payment for the Highway Commissioner to be paid by payroll deduction each pay period.

Be It Further Ordained that the salary for the Geneva Township Supervisor shall be as follows:

- 1. Salary: \$15,000.00 per year payable in equal installments on or about the first and fifteenth day of every month.
- 2. At the option of the Supervisor, if otherwise qualified, participation in the Illinois Municipal Retirement Fund (IMRF) through Geneva Township.
- 3. At the option of the Supervisor, Individual Health Insurance coverage under the insurance program(s) selected by the Township Board of Geneva Township. Participation in the Individual Health Insurance coverage shall however be contingent upon the Supervisor contributing 15% of each total monthly premium charged the Township of Geneva toward the monthly health insurance premium payment for the Supervisor to be paid by payroll deduction each pay period.

Be It Also Further Ordained, that the salary for the Geneva Township Treasurer shall be as follows:

- 1. Salary: \$500.00 per year payable in equal installments on or about the first and fifteenth day of every month.
- 2. At the option of the Treasurer, if otherwise qualified, participation in the Illinois Municipal Retirement Fund (IMRF) through Geneva Township.

Be It Additionally Further Ordained, that the salary for the Geneva Township Trustees shall be as follows:

1. Salary: \$120.00 per meeting payable quar	rterly on or about	the first of the	month.
