



Ordinance No. 12-19

GENEVA TOWNSHIP TAX LEVY ORDINANCE

An Ordinance for the levy of taxes for all township purposes for Geneva Township, Kane County, Illinois for the tax year 2019 to be collected in the year 2020.

BE IT ORDAINED BY THE BOARD OF TRUSTEES of Geneva Township, Kane County, Illinois as follows:

Section 1: That the sum of seven hundred sixty nine thousand six hundred eighty five dollars and no cents (\$769,685.00) is hereby levied upon all property subject to taxation within Geneva Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of Geneva Township as required by statute or voted by the people in accordance with the law, for such purposes as:

- a) General Corporate
- b) General Assistance
- c) Geneva Township Special Ambulance District
- d) Geneva Township Special Fire District

Section 2: That the amount levied for each object and purpose shall be as follows:

Section 5: That this Ordinance shall be in full force and effect after its adoption, as provided by law.





