SENIOR SERVICES REPORT: Greg Mills, representing the committee, welcomed Sherri Weitl as the new Geneva Township Senior Services Director. He previewed ideas for events to occur in the next two months; a possible open house during Swedish Days, and a float in the Swedish Days Parade. He stated that someone from the Kane County Health Department would inspect the kitchen to determine health requirements for the use of the kitchen. Mr. Mills announced that the committee would not take on the responsibility of certain planting areas near the building. The committee will be reviewing their policies and procedures to see if revisions may be needed.

Mr. Mills asked the trustees to approve a budget request of \$3,550.00 for a planned open house and printing of a brochure.
