## GENEVA TOWNSHIP ROAD DISTRICT TAX LEVY ORDINANCE

AN ORDINANCE FOR THE LEVY OF TAXES FOR ALL ROAD DISTRICT PURPOSES OF THE GENEVA TOWNSHIP ROAD DISTRICT, KANE COUNTY, ILLINOIS FOR THE TAX YEAR 2009 TO BE COLLECTED IN 2010.

BE IT ORDAINED BY THE TRUSTEES of Geneva Township, Kane County, Illinois as follows:

Section 1: That Highway Commissioner of Geneva Township Road District on December 17, 2009 does hereby determine and declare that the sum of two hundred eighty six thousand two hundred forty six dollars and fifty one cents ( $\$ 286,246.51$ ) is hereby levied upon all property subject to taxation within Geneva Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of Geneva Township Road District as required by statute or voted by the people in accordance with the law, for such purposes as :
a) Road Fund
b) Permanent Road Fund
c) Equipment and Building
d) IMRF
e) Liability Insurance
f) Social Security
