





ORDINANCE NO. 013 -15

AN ORDINANCE FOR THE LEVY OF TAXES FOR ALL ROAD DISTRICT
PURPOSES OF THE GENEVA TOWNSHIP ROAD DISTRICT, KANE COUNTY,
ILLINOIS FOR THE TAX YEAR 2015 TO BE COLLECTED IN 2016

BE IT ORDAINED BY THE TRUSTEES OF THE TOWNSHIP OF GENEVA,
KANE COUNTY, ILLINOIS, as follows:

Section One: The Highway Commissioner of the Geneva Township Road District on December 21, 2015 does hereby determine and declare that the sum of THREE HUNDRED SEVEN THOUSAND THREE HUNDRED TWENTY FOUR DOLLARS (\$307,324.10) is hereby levied upon all property subject to taxation within Geneva Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Geneva Township Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

- A. Road Fund
- B. Permanent Road Fund
- C. Equipment and Buildings
- D. Illinois Municipal Retirement Fund (IMRF)
- E. Liability Insurance
- F. Social Security

Section Two: That the amount levied for each object and purpose shall be as follows:

GENEVA TOWNSHIP (Unit Code 014)

Fund No. 036: Road Fund	\$ 100.00
Fund No. 038: Permanent Road Fund	\$ 247,024.10
Fund No. 039: Equipment and Buildings	\$ 100.00
Fund No. 011: IMRF	\$ 10,000.00
Fund No. 003: Liability Insurance	\$ 5,000.00
Fund No. 012: Social Security	\$ 100.00
TOTAL LEVIED:	\$ 307,324.10

Section Three: That the Geneva Township Clerk shall make and file with the Kane County Clerk, on or before the 30th day of December 2015, or may as otherwise be required by law, a duly certified copy of this Ordinance.



Section Five: That this Ordinance shall be in full force and effect upon and after its adoption, as provided by law.


